2022 – 2023 Implementation of the Eastern Corridor Road Development Programme

Ministry of Roads Ghana and Ghana Highway Authority/Financing: AfDB

The Study consisted of an assessment of trade and transport facilitation activities along the Eastern Corridor Road in Ghana. It included assessing the conditions of transit trade procedures, facilities, and infrastructure along the entire corridor to determine their effectiveness in facilitating transit trade. The goal is to establish a baseline situation for monitoring transit trade and transport facilitation along the Eastern Corridor and provide recommendations for potential improvements, including options and associated costs.

2022 – 2023 Preparation of Armenia Lifeline Roads Network Strategic Development Plan 2022-2026

The strategic study for the Armenian Road Networks focuses on several key objectives. First, it aims to define an updated definition of the national Lifeline Road Network (LRN) to be officially approved by the Government through a decree or regulation. 
